

## Capital increase and a new board: Newlisi starts a new course with an investment round of 6.5 million euros

*Environmental and social benefits with a unique solution on the market  
to reduce sewage sludge and increase biogas production:  
Newlisi invests in circular economy*

Milan, May 2022 – **Newlisi S.p.A.**, the Italian Company leader in design, construction and operation of civil and industrial sewage sludge treatment plants, started 2022 with a completely renewed look.

For the Company, this year has started with a new round of capital to support a new phase of development that aims to increase in the next five years the presence of Newlisi in Italy and abroad, thanks to the technology consolidation. The capital increase, supported by the reference shareholder 360 Capital and by the other historical shareholders, Indaco SGR S.p.A. and Micheli Associati S.r.l., consists of a total investment round of 6.5 million euros.

This important recapitalization represents for Newlisi the beginning of a new course, also marked by the designation of a new Board of Directors: the **new CEO is Edoardo Riccio**, a manager with long experience in administration and management of large groups and start-ups, consultant to funds, companies, banks and financial institutions, who also participated in the new investment round. The other members of the board are the **CFO & COO Alessandro Campanella**, expert in M&A transactions, strategic planning and investor relations, in Newlisi since 2017, and **Chicco Testa**, Chairman of Fise Assoambiente, Proger S.p.A., E.VA Energie Valsabbia S.p.A. and CEO of Telit Communications S.p.A.

Together with all these news comes a complete restyling of the brand. Newlisi new brand identity combines graphic elements inspired by the colours and shapes of technology, innovation, environment and circular economy. This new identity aims to best represent the revolutionary process of sewage sludge reduction and energy production.

Our technology allows to obtain immediate benefits from a social and environmental point of view, and it's already tested by the plants in Siena, Lecce and Grosseto and confirmed by the trust of important investors and by this new investment*

*round. In this moment of great criticality - Riccio concludes - Newlisi solution represents an immediate, concrete and easily applicable answer to reduce waste and increase renewable energy production in a circular economy scheme>>.*

Newlisi patents, developed over the last ten years and recognized in 38 countries, make the company **leader of the market in terms of performance: Newlisi process allows reductions in sewage sludge of around 70% and increases in biogas production of over 40%**, ensuring considerable savings in sludge management costs and significant environmental and social benefits.

Newlisi is an Italian Company specialized in the design, construction, and operation of civil and industrial sewage sludge treatment plants; the Company is the owner of a technological solution patented in 38 countries and based on a thermochemical hydrolysis process.

Newlisi's corporate structure includes leading investment funds focused on innovation and new technologies.

In addition to its own team of specialized professionals - coming from the fields of chemistry, purification, and plant design - Newlisi collaborates with various universities and research organizations in Research & Development, testing and process modelling.

In 2018, Newlisi obtained semi-equity financing of €15 million from the European Investment Bank (EIB) to increase technological innovation. A new investment round of 6.5 million euros was executed in 2022 to support domestic and international market development.
